## How to study at Uesc?

State University of Santa Cruz gives you the opportunity to do a study and/or research mobility in our undergraduate and graduate programs. For instance, you could join Uesc through the following programs:



**GCUB-Mob Program:** Annual call for scholarship for foreign candidates who wish to study a full master's or doctorate degree at Uesc.

**ProAfri:** Annual call for scholarship for African candidates who wish to study a full master's or doctorate degree at Uesc.



INILATmov+

**INILATMob+ Program:** Virtual and face-to-face mobility for students of graduate and graduate institutions.

**AULP Mobility Program:** Biannual call for mobility program for students of institutions from Portuguese-speaking countries and Macau.

## Which documents are required?



**Student Visa:** The candidate must provide the **Type IV Student Visa (ITEM IV)** at the Brazilian consulate in your country of origin. Check the documents required on the specific link in each consulate.

**International Insurance:** It must cover medical, laboratory and medical expenses throughout the Brazilian territory and also include funeral repatriation. The medical insurance must be acquired in your country of origin and be presented on your arrival.



**Cadastro de Pessoa Física (CPF):** Mandatory Brazilian fiscal document. It must be requested while you still in your country. [Click here](#) for more informations.

**National Migratory Register (Registro Nacional Migratório - RNM):** Issued by the Brazilian Federal Police. The best option is to schedule the attendance 15 days before the trip to Brazil. The application can be made at the [National Migratory Registration System \(SISMIGRA\)](#). After that, you must schedule an appointment with the Ilhéus unit, by clicking [here](#). Try to bring the necessary documents already organized from your home country. To check the listing, click [here](#). Also pay attention to the rules for legalization and translation of foreign documents, which you can check by clicking [here](#).



*Upon your arrival in Brazil, it is necessary to show up at the day and time scheduled with the Federal Police (see location on [Google Maps](#)). The attendance at the Federal Police must be taken place within 30 days of the student's arrival. Always check the Federal Police's website first to see if there has been any changes in the required documentation.*

## Which documents are required?



**Bank Account:** To open a bank account, the following documents are required::

- a) Identification document (documentation provided by the Federal Police, RNM, front and back) and CPF;
- b) Proof of address: A statement that can be provided by the ARINT with your current address or by the landlord of the property you rent. Preferable, the declarant should have a BB (Banco do Brasil) account. If he/she has one, he/she needs to sign as it is registered in the bank (do not rubric it). If the landlord does not have a Banco do Brasil account, a public notation is required. A current water or electricity bill should be added to the statement; and
- c) Income Proof: A statement issued by Uesc or even the acceptance letter, which states the name of the scholarship provider and the amount of the scholarship.



**Enrollment:** The following documents are required for enrollment at UESC:

- a) National Migratory Register (Registro Nacional Migratório - RNM);
- b) Cadastro de Pessoas Físicas (CPF);
- c) Enrollment Form;
- d) Graduate Diploma with the apostille of Hague or consular legalization (for master's students) or Master's Diploma with the apostille of Hague or consular legalization (for doctoral students);



Obs.: The Graduate Program may request other documents not listed above.

*For enrollment at UESC, documents in Portuguese, English, Spanish and French do not require translation. **Certified translation** is only required for other languages or in exceptional cases.*
